How to complete and submit your nomination

1- Check your eligibility

Review your eligibility for each award category.

2 - Read the conditions of entry and note the key dates, selection process and further commitments

Review the conditions of entry and key dates and ensure that you agree to these conditions, dates, and commitments.

3 - Complete the nomination form

Complete the nomination form and ensure you have filled in all sections.

4 - Address the selection criteria *

*The award criteria should be the focus of your application; however any relevant evidence may be provided so long as it does not exceed the word and page limits. The selection criteria must be addressed, and the application completed by you (the nominee). Nominators have the opportunity to briefly explain their reasons for making the nomination of the applicant in Section A. Any material in excess of the word and page limits will not be forwarded to the judging panel.

5 - Complete the declaration form

Ensure all relevant parties have signed.

6 - Sign the talent release form

Complete the talent release form and ensure you have filled in all sections.

7 - Include certificates and awards

Copy certificates and awards you have and enclose them in with your entry.

8 - Checklist

Complete the checklist to ensure you have provided everything that is needed.

9 - Submit your nomination

Collate your nomination form, selection criteria and attachments and send in your entry. All sections must be completed. Incomplete nominations will be returned to the applicant and not accepted until they are completed in full. The method for submitting your completed nomination is via email as one file to: marketing@gtntgroup.com.au

Please ensure the file size is no larger than 5MB and labelled with your full name and category.

2. READ THE BELOW

Conditions of entry:

- All applicants will need to read and agree to the Conditions of Entry prior to submitting their nomination.
- The closing time and date for all nominations is 10pm, 4 February 2024. No nomination will be accepted after this date.
- All nominees must complete a nomination form and answer all criteria. You may ask your Employment Specialist for assistance in completing your nomination.
- Nominees must meet all other eligibility criteria.
- Nominees for individual categories must be employed or managed by GTNT Group.
- Organisational categories must be an active partner with GTNT Group.
- Nominees must agree to abide by the decision of the judging panel, which is final and cannot be appealed.
- Finalists and winners must agree for their photographs, profiles and training details to be used for promotional purposes by GTNT Group and their host business.
- Finalists must be prepared to make a short video (in their workplace) for use on the presentation night.
- Finalists and winners must be prepared to be involved in promotional events and activities if required.
- Nominees must be available during the judging process for an interview, refer to key dates for specific dates.
- All finalists must be available to attend the GTNT Group Awards Night, refer to key dates for individual region dates.
- Winners of individual categories must be prepared to present a short speech upon receiving their award.

Winners of selected categories that transfer across to NT Training Award categories, need to know they will be expected (in consultation with their GTNT Group Employment Specialist) to submit a nomination form, and must make themselves available for the NT Training Awards Ceremony in September 2024, date to be confirmed.

SELECTION PROCESS

- Written applications will be assessed against the selection criteria to determine shortlisted nominees (finalists).
- Judging interviews will take place beginning of March 2024. The judges will ask a series of questions that directly relate to the selection criteria.

Before you agree to any images or audio recordings of you being used by the GTNT Group, there are some important things you need to know.

What will happen to my images once they are taken?

GTNT Group will store your images digitally in its photographic library database. The talent release form that you signed will be filed with your images. Where will my images or audio be used?
